Subject: CDOT Region 2 DRAFT Ten Year Plan FY 27 - 36

CDOT Region 2 is developing its list of priority projects for inclusion in the new Ten Year Plan that covers State Fiscal Years 2027 - 2036. For the first four years of this next Plan (FY 27 - 30), anticipated State strategic funding available for all of CDOT Region 2 is approximately \$166,000,000. Please note that the funding allocations for FY 31 - 36 are currently projections and subject to change. Historically, CDOT Region 2 has allocated Ten Year Plan funding to its two MPOs and three TPRs via the Transportation Commission-approved RPP distribution formula, which outlines an allocation target of 10.8% for the South Central TPR.

For the first eight years of the current Ten Year Plan (FY 19 - 26), total strategic funding allocated to projects in the SC TPR has exceeded the 10.8% allocation target by 0.4%. In total, 11.2% or \$78,989,648, of CDOT Region 2's Ten Year Plan funds from FY 19 - 26 have been allocated to projects in SC TPR. The proposed new Ten Year Plan allocates 11.4%, or \$20,000,000, for the first four years FY 27 - 30 to projects in SC TPR.

CDOT Policy Directive 14, approved by the State Transportation Commission in 2024, outlined three goals to be reflected through projects included in the new Ten Year Plan:

- Advancing Transportation Safety
- Fix Our Roads
- Sustainably Increase Transportation Choice

CDOT views building a transportation system that benefits all users as an important responsibility equal to the maintenance, safety, and mobility of Colorado's multimodal transportation system. The three goals listed above facilitate the implementation of the 2050 Statewide Transportation Plan by directing transportation investments in the new Ten Year Plan.

Based on these three goals and associated performance objectives, the vision for the new Ten Year Plan is: "Over the next decade, the Colorado Department of Transportation is committed to making strategic, high-quality investments in our transportation system to improve safety for all users, fix our roads, and increase transportation choice for all Coloradans."

Projects proposed to be added to the new Ten Year Plan should aim to make improvements in the key performance objectives outlined within CDOT Policy Directive 14, particularly with poor-rated and low drivability life roadway segments throughout Colorado. Additionally, "complete projects" that include active transportation and safety elements, and that also improve infrastructure conditions while supporting efficient local government land use policies, where appropriate, will have the best chance of being approved in the final version of the Ten Year Plan to be presented to the Transportation Commission. Projects containing these elements help CDOT develop a Ten Year Plan that meets statutory requirements, the administration's goals, and ensure compliance with the requirements of the Greenhouse Gas Planning Standard.
