To the SCTPR Members:

Action Item

At the January 2026 SCTPR quarterly meeting, CDOT Region 2 respectfully requests that the members of SCTPR vote to approve the following planned RPP funding additions:

FY26

1. Allocate \$500,000 FY26 RPP funds to the Region 2 Highway Paving & Maintenance of Mobility- HMA IDIQ Paving US160 Kit Carson Bypass Project.

FY27

1. Allocate \$625,000 FY27 RPP funds to the Region 2 Highway Paving & Maintenance of Mobility- HMA IDIQ Paving US160 Kit Carson Bypass Project.
2. Allocate \$2,400,000 FY27 RPP funds to the I-25 Raton Pass Wildlife Safety Improvements Project.

South Central (SC) Transportation Planning Region (TPR) Regional Priorities Program (RPP) Funding Proposals FY 30 - 32

January 29, 2026

To the SCTPR Members:

Regional Priorities Program (RPP) funds are allocated statewide at the direction of the State Transportation Commission (TC), per a formula based on 50% population, 35% on-system lane miles, and 15% truck VMT. RPP funds are a flexible funding source programmed at the discretion of each Region Transportation Director in consultation with each rural TPR and urban MPO. The general objective of RPP funding is to supplement other formula-driven funding allocations for each CDOT Region. RPP funds come from the Highway Users Tax Fund (HUTF) and other FHWA sources. The current annual statewide RPP distribution is \$50,000,000, and the historical annual CDOT Region 2 RPP distribution is approximately \$9,500,000. Based on the TC-approved RPP distribution formula, the SCTPR is **targeted** for a sub-allocation of approximately 10.8% of Region 2's total annual RPP distribution. The following proposals will result in the SCTPR being allocated approximately 10.7% of Region 2's total RPP funds as the rolling ten year average through the end of FY32.

Action Items

During the October 2025 SCTPR meeting, the following RPP-funded projects for State Fiscal Years (FY) 2030 through 2032 were proposed as informational by CDOT Region 2 staff and discussed by the TPR members. At the January 2026 SCTPR quarterly meeting, CDOT Region 2 respectfully requests that the members of SCTPR vote to approve the following planned RPP funding amounts:

FY30

1. There are no RPP funding proposals in SCTPR in FY30.

FY31

1. Allocate \$1,300,000 FY31 RPP funds to the I-25 Raton Pass Wildlife Safety Improvements project.

FY32

1. Allocate \$1,300,000 FY31 RPP funds to the I-25 Raton Pass Wildlife Safety Improvements project.
